

Item 9. Other Events

We wish to advise that on April 5, 2018, San Miguel Corporation (SMC) and San Miguel Food and Beverage, Inc. (SMFB) signed the Deed of Exchange of Shares, pursuant to which SMC transferred to SMFB, SMC's 7,859,319,270 common shares of the capital stock of San Miguel Brewery Inc. and 216,972,000 common shares of the capital stock of Ginebra San Miguel Inc. (collectively, the "Exchange Shares"), at the total transfer value of Php336,349,294,992.60. As consideration for its acquisition of the Exchange Shares, SMFB shall issue unto SMC 4,242,549,130 common shares of the capital stock of SMFB (the "New SMFB Shares"). The New SMFB Shares will be taken out of the increase in the authorized capital stock of SMFB from Php2,460,000,000.00. divided into 2,060,000,000 common shares with par value of Php1.00 per share and 40,000,000 preferred shares with par value of Php10.00 per share, to Php12,000,000,000.00 divided into 11,600,000,000 common shares with par value of Php1.00 per share and 40,000,000 preferred shares with par value of Php10.00 per share (the "Capital Increase"), which has been duly approved by the Board of Directors and shareholders of SMFB, but still subject to the approval of the Securities and Exchange Commission (SEC). Thus, the issuance of the New SMFB Shares to SMC and the transfer of the Exchange Shares to SMFB is conditioned upon the approval by the SEC of the Capital Increase.
