Ladies and Gentlemen:

We write in response to your request for clarification and/or confirmation of the Biz Buzz column entitled "Banner year" published in the February 15, 2019 issue of the Philippine Daily Inquirer. The article reported in part that:

"Last year may have been a challenging one for many business – especially those selling consumer products that were highly susceptible to inflation and tax hikes – but don't expect to find evidence of this in the financial results of the country's largest brewery.

We're talking about San Miguel Brewery which Biz Buzz heard is set to report a record breaking performance.

We snooped around and found out the brewing arm of San Miguel Food and Beverage Inc. will likely report consolidated revenue for 2018 of some P130 billion – that's a 14 percent hike over 2017's numbers.

More good numbers are set to be released, like its operating income that topped P35 billion, resulting in net income after tax rising by almost 15 percent to more than P23 billion.

We advise that the above statements with respect to San Miguel Brewery Inc. (the "Company"), the beer division of San Miguel Food and Beverage, Inc., as reported in the aforementioned article, are accurate estimates of the consolidated revenues, operating income and net income after tax of the Company for 2018.
