Item 9. Other Events

As previously disclosed, we report that San Miguel Pure Foods Company, Inc. (the "Company") has an Audit Committee Charter, the adoption of which was approved by the Board of Directors of the Company at its meeting on August 10, 2012, in compliance with the Guidelines for the Assessment of the Performance of Audit Committees of Companies Listed on the Exchange (the "Guidelines") issued by the Commission under SEC Memorandum Circular No. 4, Series of 2012. The Charter sets out the purpose, membership and qualifications, structure and operations, duties and responsibilities, reporting process and performance evaluation of the Committee.
