#### Ladies and Gentlemen:

We write in response to your request for clarification and/or confirmation of the news article relating to the Company's subsidiary San Miguel Brewery Inc. entitled "BIR blunder: Tax court orders P147 million refund to San Miguel Brewery for 'erroneous' collection", posted in Bilyonaryo.com on July 9, 2023. The article reported in part that:

"The Bureau of Internal Revenue (BIR) has been ordered by the Court of Tax Appeals (CTA) to refund or issue a tax credit certificate to San Miguel Brewery Inc. (SMB) amounting to P146.87 million.

The decision was issued by the CTA special second division dated July 5, 2023, and was signed by Associate Justice Lanee S. Cui-David.

Specifically, the order states that the amount to be refunded without legal interest represents 'erroneously, excessively, and/ or illegally collected excise taxes due on the removals of 'San Mig Light' in can, in bottle and kegs, 'San Miguel Premium All Malt Beer,' in bottle and in can, 'San Miguel Pale Pilsen' in can, 'Super Dry' in can, 'Red Horse' in can, 'San Mig Zero' in bottle, 'San Miguel Flavored Beer-Apple' in bottle, and San Miguel Flavored-Lemon' in bottle for the period covering January 1, 2018 to December 31, 2018.'

A petition for review was filed on December 11, 2019 by SMB against the BIR Commissioner for the refund of the said amount.
