Item 9. Other Events

At the meeting of the Board of Directors of San Miguel Food and Beverage, Inc. (respectively, the "Board" and the "Company") held on November 9, 2022:

1. Upon the endorsement of the Audit Committee, the Board approved the submission to SEC, PSE and PDEX of the Quarterly Report of the Company (or SEC Form 17-Q), including financial statements as at and for the period ended September 30, 2022. In the first nine months of 2022, the Company posted consolidated revenues of P261.5 billion, consolidated EBITDA of P46.7 billion, consolidated income from operations of P37.6 billion, and consolidated net income of P26.3 billion.

2. The Board approved the declaration of cash dividends on the outstanding common shares (FB) of the Company as follows:

Amount:	P0.40 per share regular cash dividend P0.26 per share special cash dividend
Record Date:	November 23, 2022
Closing of Books:	November 24 to 28, 2022
Payment Date:	December 9, 2022

3. The Compliance Officer reported that the 2022 Internal Self-Rating Form will be sent to the Directors, together with the policy and procedures, including criteria, for the annual performance assessment of the Board, intended to appraise and improve the performance of the Board of Directors as a governing unit, the individual directors, the different Board Committees, as well as the President, in accordance with the Company's Manual on Corporate Governance. A copy of the form will be available in the Corporate Governance page of the Company's website, for reference.

The Compliance Officer further reported that the 2022 Self-Assessment Worksheets will also be sent to the members of the Audit Committee, Board Risk Oversight Committee, Corporate Governance Committee and Related Party Transactions Committee for them to accomplish pursuant to their respective Charters. Copies of the worksheets will be available in the Corporate Governance page of the Company's website, for reference.

The directors were requested to return the accomplished forms to the Office of the Compliance Officer on or before December 9, 2022.

4. The Board approved the dates for the 2023 Board of Directors' and Committee meetings, as well as the Annual Stockholders' Meeting (ASM) of the Company. The ASM is scheduled on June 7, 2023, the first Wednesday of June, in accordance with the Company's By-laws. Stockholders who wish to propose the inclusion of additional items to the usual Agenda of the ASM and/or nominate candidates to the Board, may submit their proposals not later than January 31, 2023 to the Corporate Secretary at the 5<sup>th</sup> Floor, 100 E. Rodriguez Jr. Avenue (C-5 Road), Barangay Ugong, Pasig City 1604, Metro Manila, for the consideration of the Chairman and the appropriate Board Committees.
