Item 9. Other Events

At the meeting of the Board of Directors of San Miguel Pure Foods Company Inc. (respectively, the "Board" and the "Company") held on March 16, 2017:

A. The Board elected retired Gen. Ricardo C. Marquez as Independent Director of the Company and member of the Audit Committee, effective March 16, 2017, vice Justice Edgardo P. Cruz who resigned from the Board and the Audit Committee effective January 31, 2017, as previously disclosed. Gen. Marquez holds one common share of the outstanding capital stock of the Company.

Gen. Marquez, Filipino, 56, is currently a Director of the Public Safety Mutual Benefit Fund, Inc. (since July 2015). He was previously Chairman of the Board of said corporation (July 2015 to June 2016). Gen. Marquez held several positions in the Philippine National Police (PNP). In the last five years, he was Chief of the PNP (from July 2015 to June 2016), Director of Operations (from December 2013 to July 2015), Regional Director, Police Regional Office 1 (from January to December 2013), Deputy Director for Operations (from March 2012 to January 2013), and Executive Officer, Directorate for Investigation and Detective Management (from August 2010 to March 2012). Gen. Marquez holds a Bachelor of Science Degree from the Philippine Military Academy, and a Masters in Management Degree from Philippine Christian University.

- B. Upon the endorsement of the Audit Committee, the Board approved the Internal Audit Group Charter for the San Miguel Food Group, comprised of the Company and its subsidiaries.
- C. The Board declared that the Annual Stockholders' Meeting of the Company will be held on May 12, 2017, Friday, 2:00 p.m., at the Executive Dining Room, 2nd Floor, San Miguel Corporation Head Office Complex, No. 40 San Miguel Avenue, Mandaluyong City, Metro Manila.

- (ii) The stock and transfer books will be closed from April 18 to 21, 2017;
