

- 3. The Board ratified the approval by the Audit Committee of the Whistle-Blowing Policy for the San Miguel Food Group, comprised of the Company and its subsidiaries. - 4. The Compliance Officer circulated the Internal Self-Rating Form to the Directors, intended to measure Board performance annually, in accordance with the Company's Manual on Corporate Governance. Earlier during the Audit Committee meeting, the Self-Assessment Worksheet was circulated for the members of the Audit Committee to accomplish annually pursuant to its Charter, as required by the SEC.
