On January 26, 2015, San Miguel Pure Foods International, Limited ("SMPFIL"), a 100% owned subsidiary of San Miguel Pure Foods Company Inc. incorporated in the British Virgin Islands, signed an Agreement for the purchase from Hormel Netherlands B.V., of the latter's 49% of the issued share capital of San Miguel Pure Foods Investment (BVI) Ltd. ("SMPFIB"). SMPFIL already owns the remaining 51% of SMPFIB. SMPFIB is the sole investor in San Miguel Hormel (Vn) Co., Ltd., a company incorporated in Vietnam that engages in live hog farming and the production of feeds and fresh and processed meats. Following completion of the transaction, SMPFIB will be a wholly-owned subsidiary of SMPFIL.
